Client Release Authorization

In consideration of the extension of credit by the Breckenridge Building Center, Inc. (BBC), the undersigned applicant, ✓ _____ agrees to pay the BBC in accordance with the following terms and acknowledges that the BBC's extension of credit will be made in reliance upon the truth and accuracy and only after the BBC's approval of Applicant's Credit Application:

1. All account balances are due and payable to the BBC on or before the 15th day of the month following the purchase. Accounts will be in default if not paid prior to the last day of that month. Accounts in default may be closed or suspended, and the total of the outstanding invoices are subject to a late fee equal to 2% per month, 24% per year. Failure of the BBC to promptly close or suspend an account in default and/or charge late fees shall not constitute a waiver of the BBC's right to close any account in default at any time and/or seek late fees upon collection. Accounts may be reopened once payment has been received, at the discretion of the BBC. Applicant agrees to pay all costs of collection, including but not limited to, attorney fees and court costs. The BBC retains all rights to record merchants' liens when applicable, which rights may only be waived by the BBC expressly in writing.
2. Applicant is responsible for saving all copies of invoices sent with monthly statements for Applicant's records.
3. Applicant must submit a **Project Information Sheet**, provided by the BBC, for EACH project for which materials are being purchased on credit under this account, including the initial project for which this account is being established.
4. Applicant shall designate persons authorized to charge on this account. Changes in authorization will be required in writing by a Change of Authorized Signers form. BBC may refuse to allow charges by anyone not so authorized. However, release of materials to non-authorized individuals, where such material is incorporated into a project, shall not constitute a defense to any collection action or action to enforce a lien. In the event of delivery materials to the property by the BBC, the BBC need only obtain a signature of any person on site.
5. Any business applicant must notify the BBC immediately upon change of name, by executing a Company Name Change form. Such applicant must also notify the BBC in writing immediately upon initiation of dissolution, filing of a partition for bankruptcy, or any other material change to the entity's structure or legal status.

Each of the persons executing this Agreement on behalf of Applicant, warrants and represents that he/she has the full authority to execute this Agreement and bind the Applicant to all of the terms and provisions hereof.
